#### FORMATTING AND CITING REQUIREMENTS FOR STUDENT ACADEMIC PAPERS

## **APA STYLE SUMMARY**

(7<sup>TH</sup> EDITION, published in October 2019)

ISM University of Management and Economics requires students to use APA (American Psychological Association) style for formatting academic papers written in English. APA is the most commonly used style to cite sources within the social sciences.

The summary of the APA 7th edition requirements corresponds to the writing and formatting guidelines described in full in the Publication Manual of APA Style (7th ed.). It focuses on Paper Elements and Format (Chapter 2), Works Credited in the Text (Chapter 8) and Reference List (Chapters 9 and 10).

#### **General APA Guidelines**

## General format of an APA formatted paper

Student essays should be typed, double-spaced\*, on standard-sized paper A4 (210 mm x 297mm) with 1" (2.54 cm) margins on all sides. Times New Roman or similar font in 10-12 pt. size should be used.

## \*ISM recommends 1.5 pt. line spacing

Paper Format (student paper)

Page Header: Page number, appears flush right in the header (upper right corner) of all pages.

**Student papers** do not require running header.

**Font and Font Size**: Use the same font and font size throughout your paper, recommended serif and sans serif fonts:

- 11-point Calibri
- 11-point Arial
- 12-point Times New Roman
- 10-point Lucida Sans Unicode
- 11-point Georgia
- 10-point Computer Modern

**Line Spacing**: Double-space (\*ISM recommends 1.5 pt. line spacing) the entire paper. Do not add extra lines before or after headings or between paragraphs.

**Margins:** Margins are 1 inch (2.54 cm) on all sides (top, bottom, left, right)

**Paragraph Alignment and Indentation**: Left-align the text (do not use full justification). Ident the first line of each paragraph 0.5 inch (1.27 cm, one tab key).

All section labels (e.g., "Author Note," "Abstract," "References") are now bold and cantered.

### **Major Paper Sections**

Student essay should include four major sections: Title Page, Abstract (if required), Main Body, and References.

**Page Order**: Start each main paper section on a new page. Arrange pages in the following order:

- Title page
- Abstract (if needed)
- Text
- References
- Footnotes (if needed)
- Tables (if needed)
- Figures (if needed)
- Appendices

#### PAPER ELEMENTS

# **Student Title Page**

**Format:** Double-space the title page. Center each element on its own line. Do not use italics, underlining, or different font sizes.

**Title:** Concise, engaging summary of the paper and its main topic and/or variables. Write in title case: Capitalize the first letter of the title, the subtitle, and any major words of four letters or more (plus linking words "Is", "Are" and "Be"). Double-space, center, and bold the title in the upper half of the title page (three or four lines down from the top margin).

**Author Name:** Full name of each author of the paper. The preferred format is first name, middle initial (s), and last name. Center the name two double-spaced lines after the title.

**Author Affiliation**: Name of the department of the course to which the paper is being submitted and name of college or university.

**Course Number and Name**: Number and name of the course to which the paper is being submitted. Use the format shown on course materials (e.g., syllabus). Write the number and name on the same line.

Instructor's Name: Name of the instructor of the course to which the paper is being submitted.

**Due Date**: Due Date of the assignment. Include the month, day, and year in the format used in your country. Spell out the month and write the full year.

Page number: Flush right in the header (upper right corner).

# Abstract (if required)

Begin a new page. On the first line of the abstract page, center and bold the word "Abstract" (no italics, underlining, or quotation marks).

An abstract is a brief, comprehensive summary of the contents of the paper. Your abstract should contain at least your research topic, research questions, participants, methods, results, data analysis, and conclusions. You may also include possible implications of your research and future work you see connected with your findings. Your abstract should be a single paragraph, double-spaced. Your abstract should typically be no more than 250 words.

You may also want to list **keywords** (3-5) from your paper in your abstract. Keywords are words, phrases, or acronyms that describe the most important aspects of your paper. To do this, indent as you would if you were starting a new paragraph, type *Keywords:* (italicized), and then list your keywords. Listing your keywords will help researchers find your work in databases.



# **Headings**

APA style uses a unique headings system to separate and classify paper sections. There are 5 heading levels in APA. Note that all section labels, such as Abstract, Title of Your Paper, References, etc. are not considered to be headings. (All **section labels** e.g., "Author Note," "Abstract," "References" are now bold and cantered.)

The following table demonstrates how to format headings in seventh edition APA Style. All headings are bold; Levels 3 and 5 are also italic.

# **Tables and Figures**

Authors may place tables and figures in the paper either after the reference list on separate pages or embedded in the text near where they are first called out.

Tables and figures are now parallel: the formatting of numbers, titles, and notes is consistent across both (as outlined below).

Include tables and/or figures if required for your paper or assignment. When possible, use a standard, or canonical, form for a table or figure. Do not use shading or other decorative flourishes. In the text, refer to each table or figure by its number. Explain what to look for in that table or figure by calling out the table or figure in the text (e.g., "Table 1 lists..." "As shown in Figure 1..."). Either embed each table or figure in the text after it is first mentioned or place it on a separate page after the reference list. If embedded, place the table or figure at either the top or the bottom of the page with an extra double-spaced line between the table or the figure and any text.

**Tables**: Use the tables feature of your word-processing program to create tables. Number tables in the order they are mentioned in the text. Include borders only at the top and the bottom of the table, beneath 4 column headings, and above column spanners. Do not use vertical borders or borders around every cell in the table.

All tables include four basic components: number, title, column headings, and body. Write the table number above the table title and body and in bold. Write the table title one double-spaced line below the table number and in italic title case. Label all columns. Center column headings and capitalize them in sentence case. Include notes beneath the table if needed to describe the contents. Start each type of note (general, specific, and probability) on its own line, and double-space it. See sample tables on the APA Style website.

- Bold the word "Table" and the number: Table 1
- The table title is in title case and italics.
- The label and title appear on separate lines above the table, flush-left and single-spaced.
- Cite a source in a note below the table.

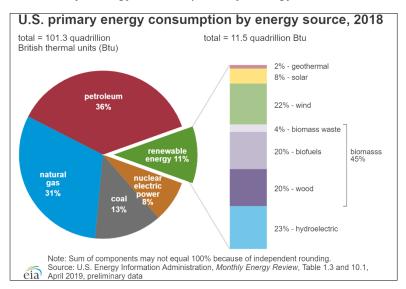
**Figures:** Use a program appropriate for creating figures (e.g., Word, Excel, Photoshop, Inkscape, SPSS). Number figures in the order they are mentioned in the text. Within figures, check that images are clear, lines are smooth and sharp, and font is legible and simple. Provide units of measurement. Clearly label or explain axes and other figure elements. All figures include three basic components: number, title, and image. Write the figure number above the figure title and image and in bold. Write the figure title one double spaced line below the figure number and in italic title case. Write text in the figure image in a sans serif font between 8 and 14 points. Include a figure legend if needed to explain any symbols in the image. Position the legend within the borders of the figure and capitalize it in title case. Include notes beneath the figure if needed to describe the contents. Start each type of note (general, specific, and probability) on its own line, and double-space it. See sample figures on the APA Style website

- Bold the word "Figure" and the number: Figure 1
- Figures now have titles, just like tables.
- The figure title is in title case and italics.

- Figures now have notes (instead of a caption) that follow the same guidelines as table notes. Figures can have general, specific, and probability notes.
- Label figures with an Arabic numeral and provide a brief but clear title. The label and title
  appear on separate lines above the figure, flush-left and single-spaced.
- You might provide an additional title centered above the figure.
- Cite the source in a note below the figure.

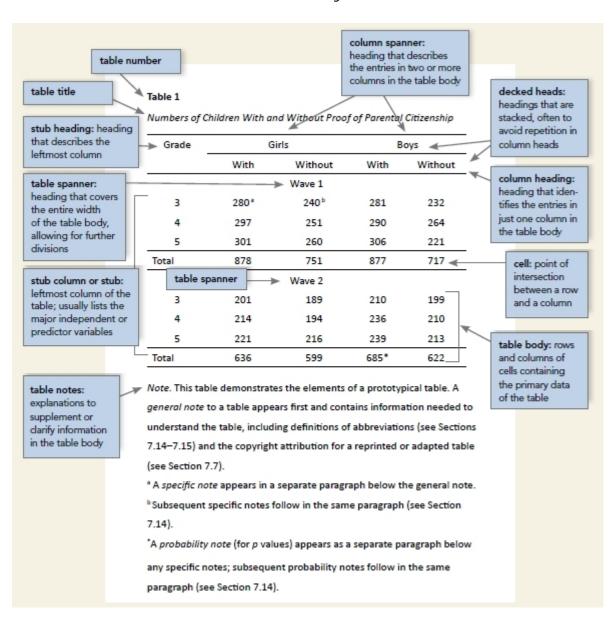

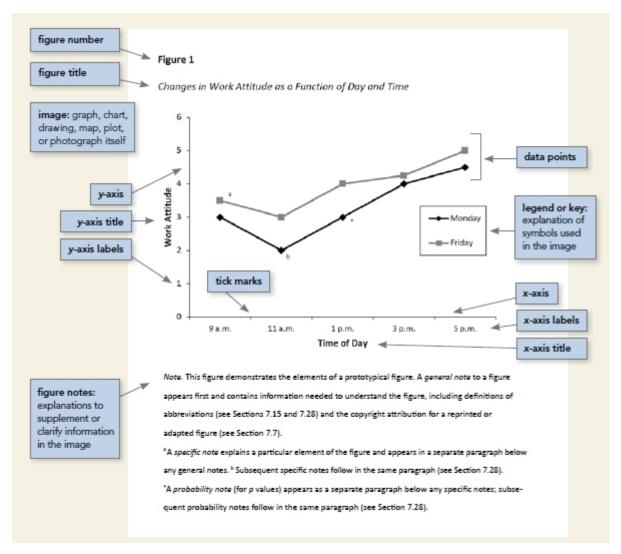
US Primary Energy Consumption by Energy Source, 2018

# In-text citation

### General guidelines

- Cite only works you read and ideas you incorporated into your paper. Include all sources cited
  in the text in the reference list (exception: personal communications are cited in the text only).
- Make sure the spelling of author names and the publication dates in the in-text citations match those of the corresponding reference list entries.
- Paraphrase sources in your own words whenever possible.
- Cite appropriately to avoid plagiarism, but do not repeat the same citation in every sentence when the source and topic do not change.
- In-text citations help readers locate the cited source in the References section of the paper.
- In-text citations follow either a parenthetical format or a narrative format.

A **parenthetical** citation includes both the author's last name and year of publication, separated by a comma, in parentheses at the end of the sentence.

e.g. Research suggests that the Purdue OWL is a good resource for students (Jones, 2018).

A **narrative** citation includes the author's name directly in the sentence, with the year of publication directly following the author's last name.

e.g. Jones (2018) suggests that the Purdue OWL is a good resource for students.

- Write author-date citations: Include the author (or title if no author) and year.
- If you are **directly quoting** or borrowing from another work, you should include the page number at the end of the parenthetical citation. Use the abbreviation "p." (for one page) or "pp." (for multiple pages) before listing the page number(s). Use an en dash for page ranges. For example, you might write (Jones, 2018, p. 199) or (Jones, 2018, pp. 199–201).
- **For paraphrases**, it is optional to include a specific page number(s), paragraph number(s), or other location (e.g., section name) if the source work being paraphrased is long or complex.

# When quoting:

- Introduce the quotation with a signal phrase
- Short quotation (less than 40 words): Use **double quotation** marks around the quotation.

e.g. As scientific knowledge advances, "the application of CRISPR technology to improve human health is being explored across public and private sectors" (Hong, 2018, p. 503).

e.g. Hong (2018) stated that "the application of CRISPR technology to improve human health is being explored across public and private sectors" (p. 503).

- Limit the use of direct quotations. Include the author (or title if no author), year, and specific part of the work (page number(s), paragraph number(s), section name) in the citation.
- Place direct quotations that are **40 words or longer** in a free-standing block of typewritten lines and omit quotation marks. Start the quotation on a new line, indented 1/2 inch (1.27 cm) from the left margin, i.e., in the same place you would begin a new paragraph. Type the entire quotation on the new margin, and indent the first line of any subsequent paragraph within the quotation 1/2 inch from the new margin. Maintain double-spacing throughout, but do not add an extra blank line before or after it. The parenthetical citation should come after the closing punctuation mark.

### e.g. Accord to Siegel and Hartzell (2004)

trauma and loss requires an understanding of the low road and its connection to patterns of experiences from the past. The passing of unresolved issues from generation to generation produces and perpetuates unnecessary emotional suffering. If our own issues remain unresolved, there is a strong possibility that the disorganization within our minds can create disorganization in our children's minds. (p. 183)

### In-text citation capitalization, quotes, and italics/underlining

- Always capitalize proper nouns, including author names and initials: D. Jones.
- If you refer to the title of a source within your paper, capitalize all words that are four letters long or greater within the title of a source: *Permanence and Change*. Exceptions apply to short words that are verbs, nouns, pronouns, adjectives, and adverbs: *Writing New Media, There Is Nothing Left to Lose*.

(**Note:** in your References list, only the first word of a title will be capitalized: *Writing new media*.)

- When capitalizing titles, capitalize both words in a hyphenated compound word: *Natural-Born Cyborgs*.
- Capitalize the first word after a dash or colon: "Defining Film Rhetoric: The Case of Hitchcock's Vertigo."
- If the title of the work is italicized in your reference list, italicize it and use title case capitalization in the text: *The Closing of the American Mind*; *The Wizard of Oz*; *Friends*.

• If the title of the work is not italicized in your reference list, use double quotation marks and title case capitalization (even though the reference list uses sentence case): "Multimedia Narration: Constructing Possible Worlds;" "The One Where Chandler Can't Cry."

## **Citing Non-Standard Author Categories**

## When the parenthetical citation includes two or more works:

- Order them in the same way they appear in the reference list—the author's name, the year of publication—separated by a semi-colon.
  - e.g. Lorem ipsum dolor sit amet (Adams, 2018; Collins, 2017).

## When citing a work with two authors:

- In the narrative citation, use "and" in between the authors' names
- e.g. According to scientists Depietri **and** McPhearson (2018), "Understanding the occurrence and impacts of historical climatic hazards is critical to better interpret current hazard trends" (p. 96).
  - In the parenthetical citation, use "&" between names
- e.g. When examining potential climate threats, "Understanding the occurrence and impacts of historical climatic hazards is critical to better interpret current hazard trends" (Depietri & McPhearson, 2018, p. 96).

# When citing a work with three or more authors:

- list the name of the first author plus "et al." in every citation.
- e.g. Lin et al. (2019) examined how weather conditions affect the popularity of the bikesharing program in Beijing.
- e.g. One study looked at how weather conditions affected the popularity of bikesharing programs, specifically the Beijing Public Bikesharing Program (Lin et al., 2019).

### When citing a work with an unknown author:

- Use the source's full title in the narrative citation.
- Cite the first word of the title followed by the year of publication in the parenthetical citation.
  - e.g. According to "Here's How Gardening Benefits Your Health" (2018)

e.g. ("Here's," 2018)

Titles: Articles and Chapters = " "

Books and Reports = italicize

**Note**: In the rare case that "Anonymous" is used for the author, treat it as the author's name (Anonymous, 2001). In the reference list, use the name Anonymous as the author.

### When citing a group author:

• Mention the organization the first time you cite the source in either the narrative citation or the parenthetical citation.

- If you first mention the group in a **narrative citation**, list the abbreviation before the year of publication in parentheses, separated by a comma.
- e.g. "The data collected by the Food and Drug Administration (FDA, 2019) confirmed..."
  - If you first mention the group in a **parenthetical citation**, list the abbreviation in square brackets, followed by a comma and the year of publication.

EX: (Food and Drug Administration [FDA], 2019).

# When citing authors with the same last names:

· Use first initials with the last names.

e.g. (B. Davis, 2018; Y. Davis, 2020)

## When citing two or more works by the same author and published in the same year:

- Use lower-case letters (a, b, c) after the year of publication to order the references.
  - e.g. Chen's (2018a) study of bird migration...

# When citing personal communication (interviews, letters, e-mails, etc.):

- Include the communicator's name, the fact that it was personal communication, and the date of the communication.
- Narrative citation:
- e.g. B. E. Anderson (personal communication, January 8, 2020) also claimed that many of her students had difficulties with APA style.
  - · Parenthetical citation:
- e.g. One teacher mentioned that many of her students had difficulties with APA style (Anderson, personal communication, January 8, 2020).
  - Do not include personal communication in the reference list.

# When citing a text with no page numbers: parenthetical citation

- Use any of the following four methods
- List the heading or section name
- e.g. One scientist noted that "A cup full of kale can help your body out in a number of ways" (London, 2019, Health benefits of kale section).
  - List an abbreviated heading or section name in quotation marks (if the heading is too long)
- e.g. One scientist noted that "A cup full of kale can help your body out in a number of ways" (London, 2019, "Health benefits" section).
  - List the paragraph number
- e.g. One scientist noted that "A cup full of kale can help your body out in a number of ways" (London, 2019, para. 2).
  - List the heading or section name and the paragraph number
- e.g. One scientist noted that "A cup full of kale can help your body out in a number of ways" (London, 2019, Health benefits of kale section, para. 2).

## When citing traditional knowledge of indigenous peoples

• use a variation of the personal communication citation above. Include the person's full name, nation or Indigenous group, location, and any other relevant details before the "personal communication, date" part of the citation.

e.g. (Caroline Jennings, Cherokee Nation, lives in Tulsa, Oklahoma, personal communication, October 2019)

## When citing indirect sources

- Generally, writers should endeavor to read primary sources (original sources) and cite those rather than secondary sources (works that report on original sources).
- If you use a source that was cited in another source, name the original source in your signal phrase. List the secondary source in your reference list and include the secondary source in the parentheses. If you know the year of the original source, include it in the citation.
  - e.g. Johnson argued that... (as cited in Smith, 2003, p. 102).
  - e.g. (Johnson, 1985, as cited in Smith, 2003, p. 102

# When citing electronic sources

 If possible, cite an electronic document the same as any other document by using the authordate style.

e.g. Kenneth (2000) explained...

# When citing unknown author and unknown date

- If no author or date is given, use the title in your signal phrase or the first word or two of the title in the parentheses and use the abbreviation "n.d." (for "no date").
- Another study of students and research decisions discovered that students succeeded with tutoring ("Tutoring and APA," n.d.).

#### **Other Sources**

The APA Publication Manual describes how to cite many different kinds of authors and content creators. However, you may occasionally encounter a source or author category that the manual does not describe, making the best way to proceed unclear. In these cases, it's typically acceptable to apply the general principles of APA citation to the new kind of source in a way that's consistent and sensible.

### References

# General guidelines

Start the reference list on a new page after the text. Center and bold the section label "References" at the top of the page. Double-space the entire reference list, both within and between entries. Use a hanging indent for each reference entry: First line of the reference is flush left, and subsequent lines are indented by 0.5 in (1.27 cm), Apply the hanging indent using the paragraph formatting function of your word-processing program. All reference entries should have a corresponding in-text citation. The beginning of the reference entry (usually the first author's surname) and year should match the corresponding in-text citation. List references in alphabetical order according to seventh edition guidelines.

 Reference list entries should be arranged alphabetically by the last name of the first author of each work.

- Create the appropriate reference entry for the type of work being cited.
- Do not create reference entries for personal communications and secondary sources.
- Each reference entry includes four elements: author, date, title, and source.
- Use punctuation to group information and separate reference elements.
- List authors in the same order as the original source. Use initials for authors' first and middle names. Put a comma after the surname and a period and a space after each initial (e.g. Lewis, C. S.). Put a comma after each author (even two authors). Use an ampersand before the last author.

# Capitalize titles in sentence case:

- Capitalize only the first word of the title, the subtitle, and any proper nouns. Format titles
  according to the type of work.
- Works that stand alone: Italicize the title (e.g., authored books, reports, data sets, dissertations and theses, films, TV series, albums, podcasts, social media, websites).
- Works that are part of a greater whole: Do not italicize or use quotation marks around the title (e.g., periodical articles, edited book chapters, TV and podcast episodes, songs). Write the title of the greater whole (e.g., journal or edited book) in italics in the source element.

Do not include database information for works retrieved from academic research databases. Do include database information for works retrieved from databases with original, proprietary content or works of limited circulation (e.g., UpToDate).

Include a DOI or URL for any work that has one. If there is no DOI, include a URL if the work is retrieved online (but not from a database). Present DOIs and URLs as hyperlinks (beginning with "http:" or "https:"). Copy and paste DOIs and URLs directly from your web browser. Do not write "Retrieved from" or "Accessed from" before a DOI or URL. Do not add a period after a DOI or URL.

#### Reference List: Author/Authors

#### **Single Author**

Last name first, followed by author initials.

Ahmed, S. (2012). On being included: Racism and diversity in institutional life. Duke University Press.

#### **Two Authors**

List by their last names and initials. Separate author names with a comma. Use the ampersand instead of "and."

# **Three to Twenty Authors**

List by last names and initials; commas separate author names, while the last author name is preceded again by ampersand. This is a departure from APA 6, which only required listing the first six authors before an ellipsis and the final author's name.

# **More Than Twenty Authors**

List by last names and initials; commas separate author names. After the first 19 authors' names, use an ellipsis in place of the remaining author names. Then, end with the final author's name (do not place an ampersand before it). There should be no more than twenty names in the citation in total.

# **Group Author**

Group authors can include corporations, government agencies, organizations, etc; and a group may publish in coordination with individuals. Here, you simply treat the publishing organization the same way you'd treat the author's name and format the rest of the citation as normal. Be sure to give the full name of the group author in your reference list, although abbreviations may be used in your text. Entries in reference works (e.g. dictionaries, thesauruses, and encyclopedias) without credited authors are also considered works with group authors.

When a work has multiple layers of group authorship (e.g. The Office of the Historian, which is a part of the Department of State, publishes something), list the most specific agency as the author and the parent agency as the publisher.

#### **Unknown Author**

When the work does not have an author move the title of the work to the beginning of the references and follow with the date of publication. Only use "Anonymous" if the author is the work is signed "Anonymous." This is a new addition to APA 7.

**NOTE**: When your essay includes parenthetical citations of sources with no author named, use a shortened version of the source's title instead of an author's name. Use quotation marks and italics as appropriate. For example, parenthetical citations of the source above would appear as follows: (*Merriam-Webster's*, 2003).

# **Two or More Works by the Same Author**

Use the author's name for all entries and list the entries by the year (earliest comes first). List references with no dates before references with dates.

## Two or More Works by the Same Author in the Same Year

If you are using more than one reference by the same author—or the same group of authors listed in the same order—published in the same year, first check to see if they have more specific dates (this recommendation is new to APA 7). Works with only a year should be listed before those with a more specific date. List specific dates chronologically. If two works have the same publication date, organize them in the reference list alphabetically by the title of the article or chapter. If references with the same date are identified as parts of a series (e.g. Part 1 and Part 2), list them in order of their place in the series. Then assign letter suffixes to the year. Refer to these sources in your essay as they appear in your reference list, e.g.: "Berndt (2004a) makes similar claims..."

## Introductions, Prefaces, Forewords, and Afterwards

Cite the publishing information about a book as usual, but cite Introduction, Preface, Foreword, or Afterword (whatever title is applicable) as the chapter of the book.

#### **Articles in Periodicals**

#### **Basic Form**

APA style dictates that authors are named with their last name followed by their initials; publication year goes between parentheses, followed by a period. The title of the article is in sentence-case, meaning only the first word and proper nouns in the title are capitalized. The periodical title is run in title case, and is followed by the volume number which, with the title, is also italicized. If a DOI has been assigned to the article that you are using, you should include this after the page numbers for the article. If no DOI has been assigned and you are accessing the periodical online, use the URL of the website from which you are retrieving the periodical.

### **Article in Print Journal**

#### **Article in Electronic Journal**

As noted above, when citing an article in an electronic journal, include a DOI if one is associated with the article.

Wikipedia articles often update frequently. For this reason, the date refers to the date that the cited version of the page was published. Note also that the manual recommends linking to the archived version of the page, rather than the current version of the page on the site, since the latter can change over time. Access the archived version by clicking "View History," then clicking the date/timestamp of the version you'd like to cite.

# **Online Scholarly Journal Article: Citing DOIs**

Please note: Because online materials can potentially change URLs, APA recommends providing a Digital Object Identifier (DOI), when it is available, as opposed to the URL. DOIs are an attempt to provide stable, long-lasting links for online articles. They are unique to their documents and consist of a long alphanumeric code. Many—but not all—publishers will provide an article's DOI on the first page of the document.

Note also that some online bibliographies provide an article's DOI but may "hide" the code under a button which may read "Article" or may be an abbreviation of a vendor's name like "CrossRef" or "PubMed." This button will usually lead the user to the full article which will include the DOI. Find DOIs

from print publications or ones that go to dead links with doi.org's "Resolve a DOI" function, **available on the site's home page**.

APA 7 also advises writers to include a DOI (if available), even when using the print source.

If an online scholarly journal article has no DOI and is published on a website, include the URL. If an online scholarly article has no DOI and is published on a database, do not include a URL or any database information. The only exception is for databases that publish articles that are in limited circulation (like ERIC) or that are only available on that particular database (like UpToDate). Note that retrieval dates are required for unarchived sources that are likely, or intended, to change over time.

#### **Abstract**

*APA* 7<sup>th</sup> edition does not provide guidance on how to cite abstracts. However, if you only use information from the abstract but the full text of the article is also available, we advise you to add "[Abstract]" after the article or source name. If the full text is not available, you may use an abstract that is available through an abstracts database as a secondary source.

### **Online News Article**

**Note:** The format for this type of source depends on whether your source comes from a site with an associated newspaper.

If the source **does** come from a site with an associated newspaper, leave the title of the article unformatted, but italicize the title of the newspaper.
